4232 -15 Apologies and introductions

Apologies were received and accepted from Councillors A Brewster (late arrival- SADC meeting) and J Shardlow (personal reasons).

4233-15 Specific Declarations of Interest & Dispensations

Councillor G Clark declared an interest in Minute 4235-15 because of her membership of St Albans District Council Plans North Committee. As a district councillor she would look at the matter afresh should any plans be discussed at Plans North.

Councillor S Haynes declared a personal interest in Minute 4245-15 as near neighbour.

4234-15 Public Speaking

Mr Peter Rudge, Architect, gave a presentation on the proposed four two bedroom apartment block dwelling development behind 3 Station Road including details of pre planning consultation, design and proposed materials (see also Minute 4235 -15). He explained how the new residents and guests would co-operate for parking with the existing shop parking of the land owners. Mr and Mrs Shifrin confirmed the acceptability of the arrangements. The area earmarked from building was adjacent but outside the High Street conservation area and following recent flood alleviation works no longer in the high risk flood plain.

Cllr Brewster arrived at the beginning of this item

4235-15 Planning Matters -3 Station Road development

The following plan was discussed and a recommendation of REFUSAL made to St Albans District Council

5/2015/1787 Jarvis - Land rear of 3 Station Road

Wheathampstead Hertfordshire Apartment block comprising four, two bed dwellings with associated parking and landscaping, demolition of brick wall and widening of crossover to facilitate access at Land r/o 3 Station Road

Concerns were raised regarding the availability of parking given the known pressure of parking in the Village centre and that the building design did not adequately reflect the adjacent conservation area.

Councillor Reason proposed, seconded by Councillor Haynes, and it was agreed, that a recommendation of REFUSAL be made to SADC on the grounds that the proposed development is near to the historic Conservation Area in the centre of the Village and does not adequately reflect the area around (Policy 70).

It also fails to meet Policy 69 (i) and (ii). The area proposed for development adjoins the Conservation Area for Wheathampstead and its proximity to the to the Conservation Area (Policy 85) and to buildings of historic interest (Policy 86) (The Old Bakery, The Mill and Wheathampstead Place) should give additional weight to the need for any development on this site to be of a scale and design which enhances this part of the Village. This application does not do this.

There is already a great deal of pressure on parking in the Village centre. It is believed that there are likely to be more requirements than one parking space per flat plus one visitor space.

4236-15 Parking in the Village

John Charlton, Environment Compliance Officer – Parking & Parking Services, SADC and District Councillor Sandra Wood spoke about parking in the Village.

Mr Charlton confirmed that HCC was to complete road repairs to Mount Road whereupon single yellow lines would be remarked.

Parking enforcement in Wheathampstead had to date been sporadic, undertaken by mobile enforcement officers. They would be asked to attend and be more visible, for example walking the High Street. A more regular 'blitz' approach was requested.

Road markings by the High Street loading/ limited waiting bay outside Tesco had become faint and inadequate. His recommendation was that it become a permanent loading bay. Parish Councillors asked that following remarking and resigning the bay, post the current resurfacing works, a trial of enforcement of vehicles parked awkwardly outside the bay be undertaken.

SADC were reviewing their parking orders. The Chairman proposed, and it was agreed, that SADC be asked to include parking orders for Wheathampstead car parks: East Lane, Memorial Hall, Folly Fields, and Butterfield Road/Old School Drive.

4239-15 Queen Elizabeth II's 90th birthday celebrations

4240-15 ATP Misuse

A number of incidents of misuse of the Artificial Turf Pitch (ATP) had been reported included burnt patches of turf, large amounts of litter and poor behaviour. Advice and observations had been sought from St Albans District Council, police and youth connexions. Quotations for electronic locks and door closures had been obtained.

The Chairman proposed, and it was agreed that this matter be discussed at a Community Involvement Committee meeting to be called as soon as possible

4241-15 Public Art

Some years since the idea of siting a wooden statue of George Bernard Shaw at the Railway station had been put forward. He had lived at Ayot St Lawrence (Shaws Corner is now in the hands of the National Trust) and was a regular user of the Wheathampstead Station. A colourful character with some controversial beliefs and causes, he was also Founder of the LSE and recipient of the Nobel prize for literature. His statue would provide a visual link between Shaws Corner and Wheathampstead's Heritage Trail.

Recent discussions with SADC had revealed that some s106 Public Art money was available.

Councillor Reason proposed, seconded by Councillor Brewster, and it was agreed that up to £2,000 be spent on a wooden statue of George Bernard Shaw, to be located at the Station Platform site, subject to the availability of s106 Public Art money.

Resolved

4242-15 Request to erect a gazebo on the Marford Field on 30 August for a christening party

A request had been received from a resident of Necton Road to erect a gazebo on the Marford Field, behind their garden gate for a christening party.

Councillor Reason proposed, seconded by Councillor Halford, and it was agreed, that as a pilot this be approved. The gazebo was to be erected and dismantled same day and it was at the resident's risk and covered by their insurance. A small charge of £50 to be made with £100 damage deposit.

4244-15 Accounts for Payment and Finance Reports

4245-15 Consultations, training and meetings

The Chairman reported on a meeting at Harpenden Town Council regarding the submission of Wheathampstead's Designated Plan Area. It was noted that SADC had subsequently approved the Area of Designation as the Parish boundary. Councillors were encouraged to familiarise themselves with the planning process, the current Local Plan, and become involved in the Neighbourhood Plan activity.

The Chairman proposed, and it was agreed, that 4 additional copies of the Local Plan be obtained to facilitate this.

Councillor Reason reported on the meeting with the Maintenance Contractor (together with Cllrs Johnston and Dante and the Clerk). He was contracted for 12 hours work re ATP maintenance, play area checks and litter picking. It had been agreed that a further 12 hours per week through August be devoted to painting agreed areas of the Memorial Hall. September priorities would be determined in the near future.

The Chairman proposed, and it was agreed that the Wheathampstead Open Spaces Volunteer are asked if they would change their planned August event to pulling and removing the rose bay willow herb (fireweed) on Marshalls Heath prior to it seeding as this was time critical. This was necessary to maintain the acid heathland environment of the ant hill areas.

It was agreed that no response be given to HCC Rail consultation nor Central Bedfordshire County Council's consultation on Community Infrastructure Levy. Councillor Clark to look at the Gypsy and Traveller and Travelling Showpeople Accommodation Needs assessment for the Strategic and Detailed Local Plans and bring back to August Council for consideration. Councillors Davies and Shardlow to look at the HCC Minerals Local Plan Consultation.

The report on schools expansion (HCC Education and Skills Cabinet 3 July) was brought to councillors' attention, particularly the increase of capital budget for the acquisition of secondary schools sites in Harpenden and Croxley Green.
